# Appendix K – Canadian Jurisdictions Restricting the Use of Exotic Animals in Circuses

Local partial bans on the use of animals in circuses exist in 27 municipal jurisdictions:

## **British Columbia**

**Central Okanagan** – By-law No. 1028 – A by-law to prohibit certain animals from being kept or displayed within the Regional District of Central Okanagan Ban on animals listed such as felids, non-human primates, elephants and "wildlife".

**Chilliwack** – By-law No. 2653 – A by-law to prohibit performances involving wild or exotic animals Ban on wild or exotic animal acts in circuses.

**Coquitlam** – By-law No. 2994, 1996 – A by-law to prohibit certain wild or exotic animals in the city of Coquitlam Ban on wild or exotic animals in circuses.

**Delta** – By-law No. 4884 – A by-law to prohibit performances involving wild animals Ban on wild animals in circuses.

**Kamloops** – By-law No. 34-28 – A by-law to prohibit certain wild or exotic animals in the city of Kamloops Ban on wild or exotic animals in circuses.

**Langley** – *By-law No.* 3461, 1994 – An exotic animals by-law Ban on wild or exotic animals in circuses.

**Maple Ridge** – *By-Law No.* 5755-1999 – A by-law to prohibit performances involving wild or exotic animals Ban on wild or exotic animals in circuses.

**Nanaimo** – By-law No. 4504 – A by-law to prohibit performances involving wild animals Ban on wild animals in circuses.

**New Westminster** – By-law No. 6849, 2003 – A by-law to regulate the keeping of animals, establish and operate a pound, provide for the licensing of dogs and for the impounding and prevention of cruelty to animals Ban on wild animals in circuses.

**North Cowichan** – By-law No. 2856 – A by-law to regulate the keeping of dogs and other animals Ban on animals in circuses with the exception of horse and pony riding and dogs.

**North Vancouver** – By-law No. 1661 – A by-law to prohibit the keeping in captivity of fur-bearing animals or wild animals, within the Corporate limits of the City of North Vancouver Ban on the keeping of wild animals.

**Oakbay** – By-law 4013 – A by-law to provide for the licensing and controlling of animals in the Municipality of Oak Bay

Ban on animals in circuses with the exception of horse and pony riding and dogs.

**Parksville** – By-law No. 1114 – A by-law to prohibit performances involving animals pursuant to the municipal act

Ban on animals in circuses except for dogs, horses and farm animals.

**Saanich** – By-Law No. 6669 – A by-law to prohibit performances involving animals Ban on animals in circuses except for horse and pony riding. **Salmon Arm** – By-law No. 2929 – A by-law to prohibit certain wild or exotic animals in the District of Salmon Arm

Ban on wild or exotic animals in circuses.

**Surrey** – Exotic Animal Performance By-law, 1993, No. 11767 Ban on wild or exotic animals in circuses.

**Vancouver** – By-law No. 6940 – A by-law to prohibit performances involving certain wild animals in circuses Ban on certain animal species in circuses including felids, elephants, non-human primates but not domestic dogs, cats and some farm animals.

**Victoria** – *Animal control by-law* Ban on animals in circuses with the exception of horse and pony riding and dogs.

### Newfoundland

**Mount Pearl** – *Place of entertainment (circuses, go-carts and amusement parks) regulations* Ban on wild or exotic animals in circuses.

**St. John's** – *Corporate and Operational Policy 09-14-02 Circuses* Ban on animals in circuses with the exception of horse and pony riding and dogs.

#### Nova Scotia

**Bridgewater** – By-law No. 176 – Circus animals prohibition by-law Ban on animals in circuses with the exception of horse and pony riding and dogs.

#### **Digby** – By-law No. 46 – Circus performance by-law

Ban on animals in circuses with the exception of horse and pony riding and dogs.

**Yarmouth** – Bylaw No. 48 – Circus animal prohibition by-law Ban on animals in circuses with the exception of horse and pony riding and dogs.

## <u>Ontario</u>

**Cobourg** – A by-law to prohibit performing exotic or wild animal shows in municipal facilities Ban on wild or exotic animal shows.

**Stratford** – By-law number ...-2003 – A by-law to protect persons from exotic or wild animals not native to North America Ban on wild or exotic animals in circuses.

#### **Quebec**

**Mount Royal** – Resolution No. 99-0820 – Global action network concerning treatment of exotic animals in exhibitions

Ban on exhibitions featuring exotic animals.

**Saint-Laurent** – Extrait du proces-verbal de la séance generale di Conseil tenue le 8 juin 1999 (Extract from the generale Board meeting minutes June 8, 1999) Ban on exotic animals in circuses.
