

**Minutes – City Centre Community Committee – June 25, 2021****REPORTS****Item No. 9                      Land Dedication Reserve Fund – Lions Pool Fort Garry Community Centre  
(Fort Rouge-East Fort Garry Ward)****COMMUNITY COMMITTEE RECOMMENDATION:**

The City Centre Community Committee recommended approval of funding in the amount of \$25,000, from the City Centre Land Dedication Reserve (Fort Rouge-East Fort Garry Ward allocation) to Lions Pool Fort Garry Community Centre, to assist with the cost of the Lions Pool Fort Garry CC Spray Pad Project, subject to the following conditions:

1.        Submission of an application to the Winnipeg Public Service. In the event an application has not been received within two (2) years of the date of the subject meeting, the matter will not be proceeded with.
2.        Confirmation from the Winnipeg Public Service that the application meets criteria.
3.        Approval of final plans and specifications for the project by the City of Winnipeg.

WHEREAS on November 26, 2020 Council adopted the Wading Pool Rationalization and Spray Pad Investment Strategy;

AND WHEREAS residents of Fort Garry are gathering support for a spray pad project based on the many benefits mentioned in the Spray Pad Investment Strategy, namely the appeal to larger demographics including 1-12 year old people, safety, longer season and accessibility;

AND WHEREAS the Fort Garry Community Centre Hobson site (880 Oakenwald Avenue) meets many of the criteria for locating a spray pad, including being a multi-use site with access to washrooms, parking and complementary site amenities like the Lion's Pool;

AND WHEREAS design and planning work is necessary to confirm the final required project budget for the new spray pad;

THEREFORE BE IT RESOLVED that funding in the amount of \$25,000 from the City Centre Land Dedication Reserve Fund (Fort Rouge-East Fort Garry Ward allocation) be recommended for approval to the Lions Pool Fort Garry CC Spray Pad Project, to assist with the cost of planning and design, subject to the following conditions:

1. Submission of an application to the Winnipeg Public Service. In the event an application has not been received within two (2) years of the date of the subject meeting, the matter will not be proceeded with.
2. Confirmation from the Winnipeg Public Service that the application meets criteria; and
3. Approval of final plans and specifications for the project by the City of Winnipeg.
