**THE AMUSEMENT TAX BY-LAW
NO. 3107/81**

**A By-law of The City of Winnipeg imposing a
tax upon persons attending places of
amusement.**

THE CITY OF WINNIPEG, in Council assembled, enacts as follows:

1. This By-law shall be referred to as "**The Amusement Tax By-law**".

DEFINITIONS

2. In this By-law

"admission price" includes

- (a) the fee or charge paid by or collected from a person for entrance to a place of amusement;

- but does not include the fee or charge paid by or collected from a person to participate in an athletic sport.

IMPOSITION OF AMUSEMENT TAX

3. (1) Save as provided in subsection (3) and section 7, every person attending a place of amusement shall, upon his every attendance thereat whether he is admitted for cash, by regular ticket, season or other periodic ticket, pass, complimentary ticket or voluntary contribution or without the payment of any fee, charge or contribution, pay to the City for the raising of a revenue of the City, a tax in accordance with Schedule "A".

OFFENCE TO ENTER WITHOUT PAYMENT OF TAX

- (2) Every person who, without having paid the tax for which provision is made in subsection (1), enters a place of amusement for the purpose of attending an amusement or participating in an amusement therein is guilty of an offence under this By-law.

PERSONS EXEMPT FROM TAX

- (3) The owner on duty in a place of amusement, or a peace officer, inspector, or other officer entering the place for the purposes of enforcing this By-law is not required to pay the tax at that place.

COLLECTION OF TAXES

4. (1) The taxes imposed by this By-law shall be collected in cash by an owner from the persons liable therefor.

REFUSAL TO COLLECT TAXES

- (2) If an owner neglects or refuses to collect the taxes imposed by this By-law, the Chief License Inspector may take such steps as he may deem expedient to collect the taxes.

REFUSAL TO COLLECT TAXES AN OFFENCE

- (3) An owner who neglects or refuses to collect the tax imposed by this By-law, or who permits or authorizes a person attending at his place of amusement without having paid the tax, is guilty of an offence under this By-law.

INSURANCE

5. (1) The City Treasurer may purchase a comprehensive insurance policy at the City's expense to protect the City against loss through the failure of an owner to collect or to remit amusement tax as required by this By-law.
- (2) The City Treasurer may provide the City's insurer with such information as may be required to obtain and maintain an insurance policy pursuant to subsection (1) including a list of persons required to collect amusement tax.

BONDING REQUIRED

6. (1) In the event that the City's insurer refuses to provide coverage pursuant to an insurance policy obtained under section 5 with respect to any owner who is required to collect amusement tax, that owner:
- (a) shall, prior to the holding of an amusement, furnish the City with a Bond of Indemnity in an amount equal to twice the sum of amusement tax that would, in the estimate of the City Treasurer, be collected by the owner each month under this By-law or with a cash deposit in like amount;
- (b) shall not permit or authorize a person to attend at his place of amusement until clause (a) has been complied with.
- (2) Every Bond of Indemnity required to be furnished under this section shall be a bond issued by a surety company registered and licensed in the Province of Manitoba, shall be in a form satisfactory to the City Solicitor, and shall indemnify the City against any loss through the failure of the owner to collect or to remit amusement tax as required by this By-law.

EXEMPTIONS FROM AMUSEMENT TAX

7. (1) Organizations operating amusements or places of amusement meeting the criteria set forth in Schedule "C" may apply for an exemption from amusement tax for that amusement or place of amusement by filing with the Chief License Inspector, at least 90 days before tickets are to be offered for sale, or at such time as may be directed by the Chief License Inspector, the following:

- (2) The Chief License Inspector shall refer applications for exemptions filed under subsection (1) to the Winnipeg Arts Advisory Council. The Winnipeg Arts Advisory Council shall analyse each application and report back to the Committee on Finance and Administration as to whether or not the application meets the criteria and intent stated in Schedule "C", with a recommendation as to whether or not an exemption should be given.

- (3) The Winnipeg Arts Advisory Council may recommend that exemptions be given for specific periods, not exceeding five years. In making such recommendations, the Winnipeg Arts Advisory Council may take into account the establishment of a schedule to periodically review all exemptions either in random order, in the order of receipt of application or by the grouping of amusements or events(s) of a similar nature.

- (4) The Winnipeg Arts Advisory Council may recommend the granting of temporary exemptions pending the receipt of further information.

- (5) Exemptions provided under this section will be subject to repeal where the organization fails to comply with this By-law, the exemption fails to meet the intent of this By-law or for any other reason at the discretion of City Council.

- (6.2) Persons attending any amusement or place of amusement set out in Schedule "E" as attached hereto are exempt from payment of amusement tax, in accordance with this section.

- (a) Within 30 days following the amusement or event(s) or at such time as may be directed by the Chief License Inspector, file:

- (i) a completed financial statement, certified by the officers of the organization or by a member of a body of professional accountants incorporated by a statute of the Province of Manitoba, on a form provided by the Chief License Inspector;
 - (ii) where part of the revenue from the amusement or event(s) was or is to be paid to a promoter, proprietor, member, officer or director, a completed financial statement indicating a final breakdown of such payments on a form provided by the Chief License Inspector.
- (b) Except as provided in clause (c), within 90 days following the end of the organization's fiscal year or at such times as may be directed by the Chief License Inspector, file an annual audited financial statement, certified by a member of a body of professional accountants incorporated by a statute of the Province of Manitoba, sufficient to indicate the value of the amusement tax exemption and to demonstrate compliance with the criteria set forth in Schedule "C".

RECORDS AND RETURNS

8. (1) The owner shall;
- (a) account to the Chief License Inspector for all tax collected;

 - (b) remit all tax collected to the Chief License Inspector as hereinafter provided;

- (c) file with the Chief License Inspector within thirty (30) days of the performance or event or, if the place of amusement operates continuously, annually, an audited financial statement or a financial statement certified by the officers of the organization including a statement of gross revenue.

- (d) permit his establishment or establishments to be entered and his books, records and other documents to be examined by the Chief License Inspector, the City Auditor, or by any persons appointed by either of them, or by any police officer, to ascertain if the provisions of this By-law have been or are being complied with and to establish the amount of tax collected or which should be collected.

- (e) include upon every ticket to his place of amusement upon which is printed an admission price of \$5.00 or more, either a statement of the amount of tax included in the ticket price or a statement that the event is exempt from the collection of amusement tax, if that is the case.

REMITTANCE OF TAX

- (2) (a) Except as hereinafter provided the tax that has been collected during any week shall be remitted before the Thursday of the following week;

 - (b) The tax that has been collected during any month upon admissions to a place of amusement which is regularly operated not less than five days of each week during at least fifty weeks of the year shall be remitted on or before the sixth day of the following month;

RIGHT OF ENTRY OF INSPECTOR

9. (1) The Chief License Inspector or any persons appointed by him may enter at any time any place of amusement

- (a) to collect the tax imposed by this By-law, if necessary;
 - (b) to place in the lobby or other part of the premises such notices regarding the tax as the Chief License Inspector may think necessary;

 - (c) to take readings of any automatic ticket vending machine used therein;
 - (d) to take stock and the serial numbers of admission tickets in the place; and
 - (e) to require the owner to produce for inspection any book, letter, paper or document relating to the place of amusement or the business thereof.

RIGHT OF ENTRY OF AUDITOR

- (2) The City Auditor or any persons appointed by him may enter at any time any place of amusement and audit of the books, records and accounts of the owner for the purpose of ascertaining the amount of tax to be collected and remitted.

SCALPING

10. No person shall sell, barter, or exchange for anything any ticket of admission to a place of amusement for a price or consideration greater than that paid or given therefor to the owner of the place of amusement to which it is an admission.

DISCRIMINATION

11. No person shall discriminate on the basis of race, creed or colour against any member of the public who seeks admission to or applies to be served in a place of amusement provided that this subsection shall not apply to organizations of a fraternal, religious or educational nature doing business only with their members or associates.

PENALTIES

12. Every person who fails to comply with the provisions of this By-law is guilty of an offence and is liable on summary conviction:

- (a) If an individual, to a fine not exceeding One Thousand Dollars (\$1,000.00) or to imprisonment for a term not exceeding six (6) months, or to both fine and imprisonment.
- (b) If a corporation, to a fine not exceeding Five Thousand Dollars (\$5,000.00).

REPEAL

13. By-law No. 843/74 and any amendments thereto made from time to time are hereby repealed.

SCHEDULE "A" TO AMUSEMENT TAX BY-LAW NO. 3107/81

(Section 3 (1))

1. On an admission price of \$5.00 or more, the tax shall be ten per cent (10%) of the admission price, but, if in making the computation of the tax the result includes a fraction, the tax shall be the whole number that is nearest to one-eleventh of the total charge made to include the admission price and the tax.

2. On passes, complimentary, season or periodic tickets, or where the person is admitted without payment of the usual or any price of admission, the tax shall be based on the admission price payable at the amusement for that accommodation.

SCHEDULE "C" TO AMUSEMENT TAX BY-LAW NO. 3107/81**STATEMENT OF INTENT**

Amusement tax exemptions are intended to assist not-for-profit cultural and athletic organizations in producing local entertainment and sporting events with admission prices at a level which will encourage a broad audience. Exemptions are not intended to apply where an amusement or event is held for the purpose of fund-raising or where the exemption would result in personal or for-profit gain.

CRITERIA

1. Exemptions will be available for events and amusements held or operated by not-for-profit cultural and athletic organizations where the events or amusements are directly related to the character of the organization. "Cultural organizations" will be interpreted to include organizations providing the following types of entertainment or amusements: musical, artistic, ethno-cultural, museums, galleries and exhibits of a non-commercial nature.

Note: Exhibits will be considered to be of a commercial nature if significant quantities of merchandise or services are offered for sale at the exhibit or if the exhibit will predictably lead to future sales.

2. (a) Exemptions will not apply to for-profit productions or performances which are mounted and assembled, outside Winnipeg and have limited local content or to for-profit touring productions which are offered through a bidding process;

(b) Where an admission price includes entertainment that would qualify for an exemption as well as a component which is mounted and assembled outside Winnipeg, an exemption will only be available if the outside entertainment forms a minor part of the complete package and does not result in an increase in the admission price that would otherwise be charged.

3. The organization is organized without share capital.

4. The governing body of the organization is democratically elected.

5. The organization is financially sound. The organization must be in a surplus position, or, at least have a sound deficit reduction plan.

6. The organization renders a service to a segment of the community while being of a general benefit to the community as a whole.

7. Less than 50% of the organization's directors are "related" persons.

Note: Individuals can be related to each other by blood, marriage, adoption, common-law relationship, or close business or corporate association (e.g., business partners, employee and employer). Individuals or groups can also be related to a corporation in which they have a controlling interest. Persons related to these individuals are also related to the corporation.

8. Related party transactions of the organization are not significant. Related party transactions shall be deemed to be significant if they comprise 20% of transactions or more than \$300,000.00 per annum, whichever is less. Significance of transactions less than 20% and \$300,000.00 will be considered on a case by case basis.

9. No part of the revenue arising from the event has been or will be paid to a member, officer or director of the organization or to a person who organizes, promotes or manages the event other than a reasonable fee, salary or commission for actual work done or services performed.

10. The organization is liable for payment of all expenses relating to the amusement or event.

11. Net revenues will be used to further the organization's undertaking.

Note: It is not intended that exemptions be used to raise funds for other organizations, although donations of a moderate amount from year end surpluses may be allowed on an exception basis.

12. Exemptions will not be available for events or amusements held or operated by individuals.
