**NORWOOD GROVE BUSINESS IMPROVEMENT ZONE BY-LAW  
NO. 8118/2002**

**A By-law of THE CITY OF WINNIPEG to maintain a Business Improvement Zone known as the "Norwood Grove Business Improvement Zone" and to facilitate its continued operation.**

THE CITY OF WINNIPEG, in Council assembled, enacts as follows:

**Title**

1. This By-law may be cited as the "**Norwood Grove Business Improvement Zone By-law**".

**Business Improvement Zone continued**

2. The Business Improvement Zone known as the "Norwood Grove Business Improvement Zone" established by the Norwood Grove Business Improvement Zone By-law No. 5649/91, the area of which is described in Schedule "A" to this By-law, is hereby continued.

**Board continued**

3. The Board established by the Norwood Grove Business Improvement Zone By-law No. 5649/91 is hereby continued and the individuals who are members of the Board as of December 31, 2002 are hereby confirmed in their positions for the duration of the terms for which they were elected, notwithstanding that their election or appointment may not have taken place in accordance with the procedures and requirement established in the Business Improvement Zone Procedures By-law No. 8111/2002.

**Composition of the Board**

4. The Board consists of

- (a) one member of Council appointed by resolution of Council; and
- (b) seven members elected or appointed from member businesses according to the procedure set out in the Business Improvement Zone Procedures By-law.

**Repeal of By-law No. 5649/91**

5. The Norwood Grove Business Improvement Zone By-law No. 5649/91 is hereby repealed.

**Coming into force**

6. This By-law comes into force on January 1, 2003.

**DONE AND PASSED** in Council assembled, this 25<sup>th</sup> day of September, 2002.

**SCHEDULE "A" TO BY-LAW NO. 8118/2002**

**THE NORWOOD GROVE BUSINESS IMPROVEMENT ZONE** is that area of the City described as follows:

Commencing on the East bank of the Red River at point of intersection with Despins Street median; thence Easterly along Despins Street median to its intersection with Tache Avenue median; thence Southerly along the Tache Avenue median to a point of intersection with Thomas Berry Street median, thence Easterly along Thomas Berry Street median to the most Easterly end of the Thomas Berry Street median, thence North-Easterly from the Easterly end of the Thomas Berry Street median to the intersection of the Seine River with the Kavanagh Street median; thence Easterly on Kavanagh Street median to its intersection with the Eastern side of Archibald Street; thence Southerly on the East side of Archibald to its intersection with the median of Lachance Street; thence Westerly from the Lachance Street median to the Seine River; thence South-Westerly to the most Easterly end of the Carriere Street median; thence Southerly on Carriere Street to the East Bank of the Red River; thence Northerly along the Red River to its point of commencement.
