EXECUTIVE SUMMARY

The Engage Winnipeg Policy (the Policy) intends to provide an approach and foundation for the Public Service to move towards more open, transparent, and accountable public engagement. The Policy is a result of dialogue and collaboration with the public, stakeholders, and internal departments.

As the Policy is applied and the contents are shaped through dialogue with the public, City departments, Councillors, and stakeholders, the Policy is intended to progress and change. The principles and approaches to engagement set out in the Policy are not proposed as a conclusive answer to improving public engagement, as new ideas and outcomes may, and should, develop over time. Continual collaboration, discussion, and capacity building are necessary for the implementation of the Engage Winnipeg Policy, and next steps, to be successful.

RECOMMENDATIONS

- 1. That the City of Winnipeg Engage Winnipeg Policy (Appendix A) be approved.
- 2. That the Public Service review the Engage Winnipeg Policy and report back to Council at a minimum of every five years on the implementation of the policy and an evaluation of public engagement at the City of Winnipeg.
- 3. That the proper officers at the City of Winnipeg be authorized to do all things necessary to implement the intent of the foregoing.

REASON FOR THE REPORT

On February 22, 2017, Council approved the Open Government Policy, which established 'participation' as one of four core Open Government principles. In addition, on June 21, 2018, Council accepted that the Audit of the William R. Clement Parkway / Sterling Lyon Parkway Extension Project report be received as information. The Public Service committed to developing a public engagement policy in response to several of the Auditor's recommendations.

Council approval is required for the adoption of a City Policy.

IMPLICATIONS OF THE RECOMMENDATIONS

The Public Service will begin working on implementing the Engage Winnipeg Policy across all City departments, and will review the policy and report back to Council every five years on the implementation of the policy and an evaluation of public engagement at the City of Winnipeg.

The implementation of the Policy will also initiate the development of a Public Engagement Framework (through an administrative standard) and comprehensive toolkit to provide guidance to the Public Service on how to implement the Engage Winnipeg Policy. The Policy will provide the foundation for more consistent public engagement, and the Framework and toolkit will provide details and tools on how to apply the Policy to the various Public Engagement projects undertaken at the City.

The administrative standard will provide appropriate guidance and criteria and a set of processes, communications, activities, events, and options for incorporating public feedback. It will also provide guidance on how to communicate with the public on how feedback will be used in the decision making process.

HISTORY/DISCUSSION

The City of Winnipeg has public engagement expertise, experience, and interest in conducting meaningful public engagement but does not have a standardized policy that is implemented City-wide. The Office of Public Engagement (OPE) has compiled input from the public, City departments, Councillors, and stakeholders to develop the draft Engage Winnipeg Policy (attached as Appendix A). Further, their feedback has been incorporated into the attached draft Engage Winnipeg Policy.

The OPE was created on January 30, 2015 to support the City's public consultation and engagement activities and is tasked with ensuring that there is consistency and

transparency in sharing information with citizens about City projects. Organizationally, the OPE is located in the City's Customer Service & Communications Department. Since permanent staff (one manager and three public engagement officers) began their positions in January 2017, the OPE has been working to understand City processes and the many ways the Public Service engages with Winnipeggers. OPE staff have been involved in over 120 projects since it was initiated in 2015. A full listing of projects is available in Appendix B. Each project has offered insight into the key principles and important aspects of public engagement that should be reflected in a relevant public engagement policy to ensure all members of the Public Service, elected officials, and the public are using the same foundation and basis for measuring meaningful public engagement.

Notable accomplishments:

- Introduction of an online engagement hub (winnipeg.ca/publicengagement), including a list of all projects, events, newsletters, and ways to get involved.
- All OPE staff trained with International Association for Public Participation (IAP2) foundations training, IAP2 strategies for dealing with opposition and outrage, and public participation facilitation training.
- Centralized hub of templates for internal access to up-to-date tools and guidelines.
- A one-year, centralized subscription for an online engagement tool, funded through the Innovation Fund. This subscription saved the City \$112,000 that would have been spent if each project (14 total) had used the software individually.
- RFP for online engagement tool released (closed on June 11, 2019); contract awarded August 8, 2019.

Policy Development

The Policy was developed through gathering input from the public and departments, discussions with Councillors, researching policies in other jurisdictions, and discussions with public engagement practitioners. The purpose of gathering feedback was to answer three key questions:

- What is working well with public engagement?
- What are the challenges?
- How can we work together to improve public engagement?

OPE's involvement in over 120 projects has provided an in-depth understanding of areas for improvement, what the public values about public engagement, areas where guidance is needed, inconsistencies, and the City's public engagement strengths. Lessons learned and best practices from City projects were a key driver in developing the Engage Winnipeg Policy. In addition, the table below outlines the key activities that contributed towards policy development.

We also received other feedback that will be applied to the Framework development and next steps.

The Engage Winnipeg Policy provides definitions, guidance as to when the policy should be applied, a vision, guiding principles, types of public engagement, and roles and responsibilities. The Policy responds to evolving public expectations for clear and consistent opportunities to become involved in the decisions that affect them.

Next Steps

The Engage Winnipeg Policy provides the foundation for consistent and transparent public engagement. There is still plenty of work to do and it will take a collaborative and concerted effort to improve public engagement and reach the vision set out in the Policy. The details on the application of that approach will be provided through the Engage Winnipeg Framework and engagement toolkit, which will be developed following the approval of the Engage Winnipeg Policy.

The OPE intends to engage the public and stakeholders over the next year to develop a comprehensive Framework and toolkit to support the Engage Winnipeg Policy and ensure the Public Service, elected officials, and the public have the resources and support available to engage meaningfully and reach the Engage Winnipeg Policy vision.
