# **EXECUTIVE SUMMARY**

Buckets & Borders Basketball Incorporated ("BnB") is a non-profit organization. It is dedicated to donating basketball infrastructure to better community spaces. The organization wants to donate basketball-related amenities to Northwood Community Centre. Placement of the infrastructure was proposed by BnB based on discussions with the local Councillor.

The scope of work for Northwood Community Centre includes:

- painting a mural onto new court material;
- installing backboards and rims;
- and installing regulation game lines on top of the mural.

The estimated value of the project is \$10,000.00 at the expense of BnB. Work is planned to be complete by September 2025.

The City of Winnipeg would commit to being responsible for ongoing maintenance and repairs of the courts after the work is completed.

The Public Service has reviewed and is supportive of the concept plan. Standing Policy Committee approval is required to accept the gift and to enter into a donation agreement.

# **RECOMMENDATIONS**

- 4. That the Proper Officers of the City be authorized to do all things necessary to implement the intent of the foregoing.

#### **REASON FOR THE REPORT**

In accordance with section 10(e) of the City Organization By-law No. 7100/97, the Standing Policy Committee on Community Services has the authority to accept or reject gifts from the public designated for use in City parks and shall make the final decision as to the location or use of same.

#### IMPLICATIONS OF THE RECOMMENDATIONS

The City of Winnipeg will be responsible for maintenance and repairs to the Project sites once completed.

# HISTORY/DISCUSSION

A request was initiated by Buckets & Borders Basketball Incorporated ("BnB") to donate basket related amenities at Northwood Community Centre Basketball courts (see map in Schedule "B" to this report). The Northwood Community Centre site is expected to be completed in 2025, and was identified by the local Councillor. Sisler High School students will play an important role in the Project.

The scope of work for Northwood Community Centre includes basketball related amenities including muralizing (colour coating) on top of resurfacer and single colorcoat, installing backboards and rims of the basketball court, and installing regulation game lines on top of the mural (collectively referred to as the "Project").

For clarity, the above works will be constructed by BnB.

The Public Works Department, Parks and Open Space Division, Planning, Property and Development Department and Community Services Department have reviewed the conceptual plans and endorse the Project.

Upon completion of the Project and final acceptance by the City, the City shall be responsible for on-going maintenance and repairs.

As the Public Service has reviewed and is supportive of the concept plan, it now requires Standing Policy Committee approval to accept the gift of the Project.
