On May 18, 2022, the Executive Policy Committee considered the Council Motion of April 28, 2022, and submitted the following to Council:

1. That Council place on record its support of the Canadian Association of Police Chiefs "four pillar approach", as outlined in Attachment A, including supervised consumption sites, decriminalization of simple possession, safe supply, and diversion and treatment, and the Policy Brief on Indigenous Harm Reduction approach including their six policy and practice recommendations, as outlined in Attachment B.
2. That the Winnipeg Public Service be directed to:
 - A. Communicate Council's support of Recommendation 1 to the Federal Minister of Public Safety and the Provincial Minister of Municipal Affairs.
 - B. Request that the Federal and Provincial Governments take action that would financially support the four pillars and six policy and practice recommendations including treatment and diversion as part of the decriminalization of simple possession of illicit drugs, as outlined in Attachment A and B.
 - C. Request an update from the Federal Government on the adoption of a framework that encompasses a comprehensive approach to address drug-related issues and obtain an update on fairness, affordability and accessibility of criminal record suspensions and the progress for Black and Indigenous Winnipeggers and report back to the Executive Policy Committee with this information.

COUNCIL DECISION:

On April 28, 2022, Council ruled automatic referral of the following motion to the Executive Policy Committee:

WHEREAS overdose data of harms and death grow year after year indicating a drug poisoning crisis in Winnipeg and urgent need for a comprehensive public health approach by all levels of government;

AND WHEREAS Criminalization makes it difficult for people who use drugs to access harm reduction services, increasing risks and subjecting them to more health and/or social harms;

AND WHEREAS the decriminalization of small amounts of drugs that other jurisdictions are considering in consultation with Health Canada does not alter the illegality of all activities associated with drug trafficking such as production and sale, which remains illegal and subject to criminal investigation by law enforcement agencies under the Controlled Drugs & Substances Act;

AND WHEREAS prosecution of drug crimes result in Black and Indigenous populations being over-represented in drug possession arrests in Canada, and convictions and resultant criminal records carries stigma that can block people from accessing housing, employment, and education;

AND WHEREAS in July, 2020, the Canadian Association of Police Chiefs issued a report titled “Decriminalization for Simple Possession of Illicit Drugs: Exploring Impacts on Public Safety and Policing” (the CAPC Report);

AND WHEREAS the CAPC Report recognizes substance abuse disorder as a public health issue and that decriminalization is a process "requiring integrated partnerships and access to diversion measures";

AND WHEREAS the CAPC Report endorses a "four pillar approach" which includes treatment, harm reduction, enforcement, and prevention;

AND WHEREAS the CAPC Report states that decriminalization does not exist in isolation, and that four elements are part of the required actions, including a) supervised consumption sites, b) decriminalization of simple possession, c) safe supply and d) diversion and treatment;

AND WHEREAS Policy Brief of Indigenous Harm Reduction written by the Indigenous Harm Reduction Advisory Committee contains six recommendations for Indigenous Harm Reduction Policy and Practice including: 1. Indigenous Community based leadership, 2. Peer lead Engagement and Support, 3. Multi-level and Multi sectoral approaches, 4. Diverse and inclusive, 5. Evidence and evaluation, and 6. Adequate sustained funding.

THEREFORE BE IT RESOLVED:

1. That Council place on record its support of the Canadian Association of Police Chiefs "four pillar approach", as outlined in Attachment A, including supervised consumption sites, decriminalization of simple possession, safe supply, and diversion and treatment, and the Policy Brief on Indigenous Harm Reduction approach including their six policy and practice recommendations, as outlined in Attachment B.
2. That the Winnipeg Public Service be directed to:
